

### **Presentation**

In the course of its 12<sup>th</sup> year, the Centre has continued to work towards goals that have characterized it since it was first founded: the development of broad empirical research, carried out with a noteable receptiveness to international collaborations and an intensive, selective, and rigorous post- graduate teaching programme designed for both foreign and Italian students.

Beyond its specific and numerous activities, the central concern of the Center was to contribute to the creation of a "research community" around which different generations of students, from the most senior professors to Masters and PhD students, could meet in a fruitful exchange of research and comradery.

This report documents the principal activities that were carried out in the Center in 2008.

#### I. Research

Despite most of the center's research being concentrated on these large substantial European projects, a considerable amount of research was also dedicated to a series of international and domestic ones.

**European Projects** 

"Integrated and United? A Quest for Citizenship in an Ever Closer Europe"

Financed by the European Union within the scope of the 6th Framework Program.

The IntUne project is one of the few Integrated Projects on the theme of *Citizenship* financed by the European Union within the scope of the 6<sup>th</sup> Framework Program. IntUne is a four year project which officially started on the 1<sup>st</sup> of September 2005 and is coordinated by the University of Siena via the CIRCaP center. It involves 29 European Institutions and over 100 scholars across Central and Western Europe. Its geographical and disciplinary integrating capacity as well as the joint effort of many scholars and practitioners specialized in different fields (political science, sociology, public policy, media, linguistics and socio-psychology) clearly represent a step forward in the strengthening of the European Research Area in social sciences and humanities in general. Along with the two main project coordinators, Prof Paolo Bellucci, Nicolo Conti and Prof Luca Verzichelli also played an important role managing some of the working groups and undertaking the project management itself.

IntUne aims at studying the changes in the scope, nature and characteristics of citizenship that result from the deepening and enlargement processes of the European Union. Now that the EU is facing an important number of challenges, and given that its democratic capacities and legitimacy are questioned, it is important to address the issue of *if* and *how* EU citizenship is emerging. The project focuses on how processes of integration or disintegration, at both the national and European level, affect three major dimensions of citizenship: identity, representation and scope of good governance. Problems of citizenship will be addressed under this threefold approach by looking at the relationship between both the public and elites and between European and domestic dimensions of political life.

From this primary question stem three further sets of questions representing the building-blocks of this research:

- In what way does a particular kind of political structure (the EU) shape citizenship? In such a complex system, how do/can different identities coexist?
- What sense of obligation is the EU citizenship developing? How do coexisting identities affect the relationship between elites and the public?
- What are citizens and Elites expecting from the EU as a level of European government?

#### 2008 Activities:

All the research activities that took place for the project this year are listed (along with their main objectives and results) in the following set of work packages below:

#### **Integrated Theoretical Framework:**

The objective for this part of the research was to produce a theoretical review of the literature on relationship between the mass, elites, experts and the media regarding the activities of producing and reproducing identity, the mechanisms of representation and the functions of governance. Moreover, we provide the project with an integrated theoretical framework for the different levels of analysis.

A series of conferences were organised, or included the participation of some members of the project, in order to discuss the preliminary results of the analysis. Among these was the IntUne conference held in Granada (May 8-11) and the panel that was present at the annual conference of the American Political Science Association (August 26-30).

The results of the analyses conducted in this part of the research will be compiled in the following volumes of the next publication by Oxford University Press: National Identity and European Identity, edited by Bettina Westle e Paolo Segatti Political Representation in the European Union: Mass-Elite Congruence Regarding Matters of Identity, Polity, and Policy, edited by Hermann Schmitt e Lieven De Winter.

# Secondary Analysis of the surveys and addition to the project "Beliefs in Government (BiG)"

A key phase in the project, prior to conducting the original analysis of public opinion, concerns the secondary analysis of a vast collection of data gathered through numerous projects and institutions, among which are Eurobarometer, the World Value Survey, BiG, ESS and ISSP, and others related to the political orientation of the European public.

The results of this analysis will be compiled in the forthcoming volume of *Citizens and the European Polity: Mass Attitudes Towards the European and National Polities*, **edited by** David Sanders, Pedro Magalhães, André Freire, and Gábor Tóka, also put out by Oxford University Press.

#### Mass Survey

The mass survey aims to analyze the impact of European integration on the political culture of its citizens. A particular emphasis is placed on the political support of citizens with reference to the problems of identity, representation, and levels of government. Throughout the course of 2008, the principle objective of this part of the research was

to empirically test the project's theoretical framework on the data from the first wave of the survey, which was conducted in 17 countries in 2007. A series of research reports were produced which were presented on various occasions at conferences both internal and external to the project, among which was the IntUne conference in Lisbon (November 27-30).

#### **Elites Survey**

The primary goal of the survey conducted on the national elite is to highlight the perceptions and visions of the EU of this particular portion of the population.

Over the course of 2008, the principal objective of this part of the research was to empirically test the project's theoretical framework on the data from the first wave of the survey, which was conducted in 17 countries in 2007. A series of research reports were produced which were presented on various occasions at conferences both internal and external to the project, among which was the IntUne conference in Lisbon (November 27-30).

Furthermore, the results of the analysis will be compiled in the next published volume of *The Europe of Elites. A Study into the Europeanness of Europe's Economic and Political Elites*, edited by Heinrich Best, Daniel Gaxie, György Lengyel, Oxford University Press.

#### **Government and Party data Collection**

The aim of this part of the research is to analyze the attitudes of national parties towards the EU and their specific preferences regarding the process of European integration. This study was conducted through a content analysis of a large number of official party documents, gathered specifically for this analysis.

In 2008, some of the results made their way into articles published in national and scientific journals.

#### **Network and Elites Career Analysis**

The main objective of this analysis is to understand: 1) if and to what extent the most specialized national political elites are involved and organized within the European network; 2) if a new model of the European political career is emerging in connection with the EU's system of multi-level governance.

To this end, a remarkable mass of data was gathered on the profiles and careers of the national political elites in 17 European countries. Over the course of 2008, the main results were presented in some conferences, among which was the IntUne conference in Granada (May 8-11). They were also compiled in a report and submitted in the form of an article to an international scientific journal.

#### **Deliberative Polling**

The experiences of deliberative polling which are organized by the project have as their main objective the elaboration of new forms of popular participation in decisional processes of the government. After the experience in Torino in 2007, the first of its kind in Italy, in 2008 an analogous intiative was organized in Kaposvàr (Hungary). The results of the two research experiences were presented in the form of articles published in national scientific journals.

#### **Media Analysis**

This part of the research consists of compiling, codifying, and analyzing journalistic corpus and has as its aim understand how citizenship is represented in the public discourse of the media. Throughout 2008, an international event was orgnized in Rome (February 28-29) at which the preliminary results of the research were presented. Moreover, the final results will be compiled in the forthcoming volume of *European Identity: What the Media Say*, edited by Paul Bayley e Geoffrey Williams, Oxford University Press.

#### **Project Management**

The project is coordinated by the University of Siena vis à vis CIRCaP, which assumes all of the responsibilities/ accomplishes all of the tasks of project management and of the conducting of research regarding contracted work with the European Commission. The managerial activities specifically concern control over the management of organizational and financial procedures put into practice by the Consortium and the annual reporting to the commission both from a scientific and financial point of view. Moreover, the aspect of coordination consists in the involvement of all of the partners who are engaged in the project, in the distribution of resources within the consortium according to the research duties, in the development of solutions to potential problems that might be encountered during the carrying out of the 4 year research activity and the promotion of the activity of publishing its scientific results. Throughout 2008, among the activities of the ordinary handling of project, a few deserve a special the international conferences at our partner institutions: Granada (May 8-10), Lisbon (November 27-30) and Cardiff (September 12-13), and the submission of the annual report to the European Commission.

#### EUROPOLIS: A Deliberative Polity-Making Project

Europolis started on the first of September 2008 and brings together a team of European Universities all coordinated by the University of Siena, via the CIRCaP center. It is financed by the the 7<sup>th</sup> Framework Program of the EU and by a network of foundations headed by the Compagnia di San Paolo<sup>1</sup>.

The project intends to test whether <u>deliberative democracy</u> can contribute to address the democratic deficit in Europe, with particular reference to the next European parliamentary elections.

Europolis is organizing an event which will take place on the 29<sup>th</sup> of May 2009 in Brussels . This Deliberative Polling (DP), the first to be held on a European level, will debate the themes of immigration, climate change, and the EU policy- making process- a unique experiment in informed decision-making.

A sample of 400 citizens will be invited to discuss these themes in small working groups, and then in plenary sessions with a battery of experts and election candidates. The participants will be interviewed before before, during, immediately after, and again a few days after the European Elections in 2009. Their opinions will then be compared to a to control group – a sample not present at the DP – who will also be interviewed during the sampling time and again after the Elections.

This post electoral survey should reveal whether or not the citizens present at the DP change their opinions towards the EU as a result of the DP experience. It should also reveal to what extent and how their voting opinions have changed.

The approach taken by EuroPolis provides a real opportunity to assess, in a vigorous way, to what extent the exposure to complete and balanced *policy* information as well as the deliberation and discussion undertaken during the Elections can influence the knowledge and voting behaviour and turnout of citizens.

# PRIN Project 2007-2009 financed by the Italian Minister of Education, of University Study, and of Research

National Coordinator: Maurizio Cotta

Launched on September 1, 2008, the project aims to explore, from a variety of perspectives, the transformation of Europe that is currently underway. The current phase, seen through the lens of the Constitutional "big change" that Europe had foreseen, appears to be one of crisis or even of failure. However, as demonstrated by the past experience of the development of a supranational European polity, less visible, incremental and intersticed changes are often as significant as more visible and dramatic ones. In light of this reality, the three related research units maintain that, in order to better understand the actual state of the European integration process and its evolution, the attention of researchers can be usefully focused towards some aspects that are less directly invested in the big constitutional issue but that are nonetheless important to the continual process of adaptation and transformation of the European political system.

In the context of this project, the Siena unit, represented by a group of CIRCaP's researchers, is developing a research plan related to the following problem areas: The "variable geometry" of representation in a complex polity: supranational and national representative actors and mechanisms in the context of an integrated Europe". In general, Siena's research unit aims to analyze some strategic aspects of the "representative sub-system" of the European Union through the lens of multiple paths of European representation by analysing the role of leaders, parties and parliaments with particular attention to the relationships between the national and supranational consolidated dimensions of representation. The issue is of particular relevance, as there is a widespread discussion currently underway both in political and academic spheres. It centers on the political-constitutional aspect of the EU and its correspondence to standards of democracy that Europe has for some years begun to systematically adopt within the procedures of enlargement.

Given the nature of European construction it is also evident that the "representative sub-system" has a much more composite character and a less linear one than the national systems. It is articulated in fact in three fundamental "instutional paths" that can be identified within the process of community decision-making: within the communitytechnocratic path of relations between the Commission and the system of organized interests; in the community-Parliamentary path of elections and of the European Parliament, with the surrounding of the European party federations; and finally in the national-parliamentarygoverning path based on the participation of national government leaders who are accountable at the domestic level through classic parliamentary mechanisms. The and representation therefore presents itself as a complex "composition" of the results of processes that are carried out within these paths of interaction.

The Siena research unit (Sabrina Cavatorto, Nicolò Conti and Maurizio Cotta) sets out to focus on some aspects which are essentially related to the second and third "institutional paths". These paths have not yet been sufficiently explored and instead appear relevant for a better knowledge and comprehension of the trend and of the problems of European representation.

### **Public Opinion and Political Behaviour**

#### Transatlantic Trends

Since 2002, Pierangelo Isernia has been the scientific advisor of the Transatlantic Trend Survey, a project sponsored by the German Marshall Fund in the United States and Compagnia di San Paolo, with the support of Fundação Luso-Americana (Portogallo), of the Fundación BBVA (Spagna) and of the Tipping Point Foundation. The survey conducts a yearly analysis of the view that American and European citizens have of one another. Furthermore, it examines their respective opinions on a series of global threats, on foreign policy and on security, in the context of transatlantic relations.

Since 2006, CIRCaP also conducts a European Elite Survey, thanks to the financial support of the Compagnia di San Paolo. The survey uses a sample of members of the European Parliament of 9 states that already take part in the Transatlantic Trend Survey, as well as a sample of 100 high-level European functionaries recruited within the Commission and the Council. The survey anticipates that the Transatlantic Trend questionnaire will also be administered, with the aim of revealing the opinions of European Elites on a series of issues and creating the possibility for a comparative analysis with public opinion.

Furthermore, since 2007 the Transatlantic Trends on Immigration conducts a yearly examination of the attitudes and policy preferences on immigration issues in Europe, Canada and the United States. Pierangelo Isernia is one of the members of the Advisory Committe of the project (together with Susan Martin, Director of the Institute for the Study of International Migrations at Georgetown University and Claudia Diehl, Researcher in Migration and Ethnicity at the University of Göttingen).

In order to consolidate these experiences, in the course of 2008, an agreement was signed by the Compagnia di San Paolo, the US German Marshall Fund, and the University of Siena *vis a vis* CIRCaP. The goal of the agreement is the rationalization of the entire process of creation, management and data analysis related to the three aforementioned projects.

CIRCaP contributes to this initiative through the following activities:

- Scientific consultancy in the stages of preparation of the questionnaire and pre-test;
- creation of the European Elite Survey (with the support of Compagnia di San Paolo);
- organization of data banks;
- analysis of the data disseminated through research reports
- data management with the aim of making the data banks more widely available to the public.

It is worth mentioning the general agreement signed in December 2008 with TNS Opinion, through which a collaboration was effectuated with CIRCaP in scientific research and in the sector of public opinion and opinion surveys. The activities involve students enrolled in the programme at CIRCaP and will be coordinated by Pierangelo Isernia (Director LAPS, Laboratorio Analisi Politiche e Sociali) and Luca Verzichelli (Coordinator Master 2<sup>nd</sup> Level Politics and Society in Europe). The activity of cooperation will be financed by funding that TNS is making available to CIRCaP.

#### Italian National Election Studies (ITANES)

ITANES is the acronym for the Italian National Election Studies (Italiano di Studi sulle Elezioni Nazionali) programme. The programme originated in the beginning of the 1990's when, in the context of a project on the transformations of the Italian political system, the Cattaneo Institute conducted two post-electoral surveys (in 1990 and 1992) and created a Standing Group on political transition. Since 1994, when the first elections were held with the plurality system, the group has been enriched by the researchers of many Italian universities who comprise the group ITANES.

Their principal goals are the following:

- a) produce surveys for each Italian election
- b) publish academic works
- c) make data banks accessible to the international community

Paolo Bellucci of Siena's CIRCaP is a member of the project's Steering Committee, along with Piergiorgio Corbetta (University of Bologna), Patrizia Catellani (Catholic University of Milan), Marco Maraffi (University of Milan) Paolo Segatti (University of Milan), Salvatore Vassallo (University of Bologna).

Furthermore, Prof. Bellucci is the Scientific Coordinator of a project of the ITANES group which is focused on the study of the electoral cycle 2008-2011 (Electoral cycle and political change in a multilevel system: public opinion dynamics between European, National and Regional Elections).

The end product of this research is the last volume of a recent ITANES programme, *The Return of Berluscon*i, which examines the electoral behaviour of Italians during the political elections of 2008.

#### Comparative National Election Project (CNEP)

CNEP studies the political and social transformations in democracies (new and consolidated). The project involves an international group of scholars, among which Paolo Bellucci plays an important role. Prof. Bellucci prepares empirical studies of a comparative nature through the implementation of a common system of data-gathering in the context of the various researches of the National Electoral Study (NES).

The most recent research projects of CNEP focus on the study of the social determinants and of the intermediaries (groups, associations and media) of the vote in Europe, North and South America and Asia. Furthermore, research has been dedicated to such areas as that of democratic support, of cleavages, and of political behavior in a vast number of democratic and quasi- democratic regimes in Africa, Asia, Europe and America.

# **Comparativie Analysis of Government Institutions**

In 2008, CIRCaP created an Observatory on Istitutional Change under the coordination of Luca Verzichelli, with the aim of harmonizing the numerous research activities on the elites and institutions currently underway in the Center. The principal focus concerns political and institutional change in Italy. Furthermore, the data and the research experiences available cover a more vast area of comparative knowledge. The scholars at CIRCaP are, in fact, experts on Italy in a wide number of research projects on an international scale. They coordinate studies for the Observatory in the context of these projects, among which are comparative studies.

The research interests and activities developed at the Observatory currently include:

- an archive on the members of parliament in Europe
- an archive on the Italian political class
- a study of the legislative activities of the Italian government
- research on the popularity of the Italian government
- a study of the relationship between political elites and their respective domains in Italy
- an analysis of the normative reforms in the EU and of the normative?
   agencies in Italy
- a study of political discourse and of electoral manifestos

### The government in the legislative arena: commitments, actions and strategies

PRIN Project 2007-2009 financed by the Italian minister of Instruction, of University studies, and of Research

The project, included in a research of national interest on decisional and legislative processes which is directed by Marco Giuliano (University of Milan) aims to develop the interpretation of the changes in the relations between Italy's government and its parliament, with reference to legislative production. Issues such as steering capabilities, the drifts of presidentialisation and the strengthening of the core exectutive are well-known by students of institutional comparative analysis. In the study of the Italian case, these phenomena currently find great expectations of

change, based on the efficiency of the relevant measures that have redefined the functioning of the government and also its interaction with the legislative without even retouching, up until today, the consitutional picture of the parliamentary system.

The Siena research unit has set as its objective the formulation and testing of its hypothesis about the evolution of government-parliament relations in the context of the legislative processes. In particular, the types of factors will be investigated are: 1) political-institutional factors (party veto-players, nature of the coalition and types of government); 2) procedural and strategic factors ( the different rules within government-parliament dynamics and the different techniques that the government puts into play to develop its policy-making role, 3) factors related to the specificity of the interests at stake (political contingencies, political electoral cycles, the nature of decision-making and of policy).

In the course of 2008, research unit has begun to develop some research interconnected paths that have been largely unexplored in the major literature: 1) the study of legislative "commitments" and the classification of objectives advanced by the executive through a codebook derived from the methodology of the comparative analysis of policy agendas, 2) the study of action and of the strategies of the government in parliament; 3) the study of government-parliament relations in a sector limited under the procedural profile, but rather vast in terms of the number of acts and the scale of policy contexts: the process of balance.

### **Archives and Documentaion**

Throughout 2008, CIRCaP continued to compile a rich documentation on the phenomena inherent to political change. Over the years, the numerous requests for access to these archives made by scholars in the international community have made CIRCaP a point of reference for the gathering and distribution of data for empiral research. The following is a more synthetic presentation of the principal resources which are available in the Centre:

- I. International Poll Data archive (surveys and research on public opinion in Europe and America). Currently, the archive contains 120 international surveys conducted between 1952 and 1999. Coordinator: Pierangelo Isernia.
- II. Ministri in Europa (1945-1980). Data bank originally compiled by Jean Blondel and later developed under the coordination of Luca Verzichelli.
- III. DATA CUBE, data bank on the recruitment of the parliamentary class in Europe from 1848-present. The archive currently includes data on 12 European countries. Coordinators: Maurizio Cotta and Heinrich Best (University of Jena).
- IV. *PARLIT.* Archive on the parliamentary elite in Italy. Coordinators: Maurizio Cotta e Luca Verzichelli.
- V. Government Programs in Italy (from 1976- present). Documents compiled in hard copy. Responsabile Luca Verzichelli.
- VI. Electoral Programmes and documents on European Party Discourse. The archive contains a myriad of documents among which are the Italian electoral programmes from the post-war period to the present as well as an abundant documentation of documents related to political discourse about Europe in 15 EU countries. Coordinator: Nicolò Conti.

VII.

The Italian government and the critical junction. Data bank on the positions of the Italian elite regarding the principle international and European challenges, mainly revealed through an analysis of the press. Coordinator: Sabrina Cavatorto.

# III. Postgraduate Teaching

In 2008, the two traditional programmes were carried out at CIRCaP: the Masters in 'Politics in Europe' (Director Luca Verzichelli) which reached its tenth year and the Doctoral programme 'Comparative and European Politics' (Director Pierangelo Isernia passed the torch to Paolo Bellucci), which completed its ninth year. Both programmes are taught in English and both are attended by European and non-European students.

Furthermore, the Center offers training courses specific to methodology and on the use of particular statistics software (i.e., SPSS, STATA).

All of these initiatives are supported by the Faculty of Political Science at the University of Siena and by the Department of Historical, Juridical, Political and Social Sciences.

# Visits to European institutions and to the General Headquarters of NATO

As occurs every year, at the end of the second semester of study, the Centre's Graduate School organized a visit to Brussels for the Masters students and first year doctoral students. For the 2007-2008 academic year, thevisits guided by Silvina Cabrera and Nicolo Conti were held at the European Commission, the Council, the European Parliament and NATO. Each visit was characterized by a programme of seminars in which the speakers were functionaries of the aforementioned institutions.
